

CONSENT TO THE PROCESSING OF PERSONAL DATA

Identification of the personal data controller

AGREEMENT

1. Purpose of consent

This consent is granted by the Customer within the scope of the purposes listed below so that the Company can process his personal data as part of its activity.

As part of this consent, the Customer confirms that he has been informed of the basic rights regarding the protection of his personal data, the definition of individual personal data, their classification and the ways in which the Company deals with them, and these are detailed in the so-called Information Sheet, published on the website Companies.

2. The purpose of personal data processing

The customer hereby grants the Company consent to the processing of personal data for the purpose of sending information about changes in offered services, discount promotions and other business communications, when the Company processes personal data in accordance with the relevant legislation. 3. Time of personal data processing

The Company informs the Customer, and the Customer acknowledges and agrees that its personal data will be kept for the duration of the validity of this consent given by the Customer to the Company, at the latest for a maximum period of 10 years or longer if required by applicable law. After the expiration of the period for authorized processing of his personal data by the Company, either due to the expiration of the period established by this consent or due to the relevant legal regulation, the Company will delete the given personal data.

4. Processing of personal data

The customer acknowledges and agrees that the provided personal data can be accessed by designated employees of the Company and processors who are listed in the overview in the record of processing activities.

5. Change of personal data

The customer can notify the change of the provided personal data to the contact person designated to manage the personal information protection agenda, or use their other rights according to the Information Sheet. The link to this contact person is publicly available on the Company's website.

6. Revocation of consent to the provision of personal data

The customer is hereby informed that he has the right to revoke this consent at any time, but the revocation does not apply to personal data processed by the Company on the basis of another title, especially within the scope of the fulfillment of any contractual relationship or from the relevant legal regulations, although the Company ceases to be entitled at the moment of revocation of this consent process these personal data for the purposes defined by this consent.

7. Information notice

The Customer acknowledges that the Company is committed to protecting the Customer's personal data in an adequate and appropriate manner, and has taken measures for this

purpose described in more detail in its internal directive for the protection of personal data as well as in the Information Sheet.

8. Statement of Consent

Customer expressly declares that this consent is:

- i. free, that is, not confined under duress or distress;
- ii. specific, i.e. it contains clearly defined purposes for the processing of personal data, which the Customer has understood;
- iii. informed, i.e. that the Customer has familiarized himself with the full text of this consent and understood it.

The Customer confirms that the personal data provided to the Company is true and accurate.

The customer agrees to the Company processing the provided personal data only to the extent and for the purpose specified in this consent, in the sense of the above.
